YMCA character values must be displayed by all (Caring, Honesty, Respect and Responsibility); we have a 3-strike policy for less severe incidents.**

2. YMCA staff may take children on walks in the areas surrounding the school buildings as part of their exercise routine.
3. Our after-school site focuses on homework, arts & crafts, educational activities and physical recreation. Swimming is provided at the West Family branch.
4. Light snacks are available; your child may bring their own if allergies or other situations exist.

### School Activities

Children leaving the YMCA to attend sports, lessons, etc. within the building will not be released without an adult supervising them. It is your responsibility to get the proper supervision for your child; staff cannot be responsible for any programming that is not related to the YMCA. You must hand in a signed and dated note stating your child's absence as a safety measure.

On occasion your child may stay after school with a teacher; if so, we will need a signed and dated note from the parent. This will release the YMCA from the responsibility of your child during that time. Teacher must bring child to program.

I understand that upon my arrival, the YMCA is no longer responsible for my child. I understand that I must sign my child out each day along with the time of departure. I am fully aware that the YMCA is not responsible for my child when my child is involved with other activities that I have given permission to attend such as: sports, dance, tutoring, etc.

The undersigned, individually and as a parent or guardian of the participant hereby authorize The Broome County YMCA School Age Child Care to carry out any measures deemed necessary should an emergency occur, including securing at the expense of the undersigned, appropriate medical treatment for the participant, and hereby, released the Broome County YMCA, its employees and agents from any and all liability or claims arising out of participant's engagement in the above described event.

## **Incident Reports**

Your child will be given 2 verbal warnings for inappropriate behavior; on the receipt of a 3<sup>rd</sup> warning, an Incident Report will be written and given to the parent to sign. A copy will be made for the Administrator of the YMCA School-age Programs; parents may receive a copy upon request. If a child receives 2 incident reports, the child will be suspended for a day; another series the suspension moves to 2 days and if a 3<sup>rd</sup> series occurs, your child will be removed from our program.
